HSI UNVEILS \$1.25 MILLION RENOVATION AT ITS FIRST FLOOR MAIN FACILITY RIBBON-CUTTING

It was with much fanfare, including loads of media attention, that Habilitative Systems, Inc. (HSI) held a ribbon-cutting to mark the grand reopening of its newly renovated first floor of its headquarters, the Larry T. Byrd Administrative Building, at 415 S. Kilpatrick Avenue. The \$1.25 million upgrade reflects HSI's ongoing commitment to delivering critical behavioral health and human support services to Chicago's most vulnerable communities.

Named after HSI's first executive director, the building has been the heart of the organization since 1978, serving as a hub for behavioral healthcare, housing support, employment readiness, youth services, and much more.

With 17 locations now operating throughout the South and West sides, HSI continues to be a vital safety-net for thousands each year.

"Now more Chicagoans will have access to expanded services thanks to our renovation," said HSI President and CEO Donald J. Dew during the ribbon-cutting, which drew dozens of community leaders, elected officials, and partner organizations.

Chicago broadcast, print and digital media also supported the ribbon-cutting with CBS2 airing the story three times.

Key renovations include an Integrated Employment Center, a new Mindfulness and Therapy space, First Aid Room, ADA-compliant lift, and a completely redesigned front entrance and lobby with upgraded flooring, lighting, and accessible features. The updates not only

Based on our HSI five-year impact report, we've seen extraordinary outcomes:


- Serviced 8000 clients in core programs including mental health, substance use treatment and developmental disabilities.
- 96 % of clients gained access to essential food security through case management.
- 100% of youth in our mental health programs avoided hospitalization.
- 85% of individuals in our substance use recovery programs remained sober.
- And recidivism among youth in our court-linked mental health services? 0%.

We know that HBCBOs around the country are equally successful. Together, we're not just treating symptoms—we're building systems of care that affirm dignity, foster resilience, and support long-term stability.

From permanent supportive housing and emergency shelter to crisis counseling, gun violence prevention, and workforce development—our programs are reaching more than thousands of people each year with services that are trauma-informed, culturally competent, and rooted in the lived experiences of those we serve.

enhance functionality but also improve the overall experience for clients and visitors.

A major highlight of the project is the new Technology Lab which was made possible by a \$100,000 contribution from ProvenIT. The 14-station lab expands digital access for clients of all ages—offering training in job readiness, resume development, online instruction, and even app and game coding for students.

Funding for the renovation was secured through the collaborative efforts of HSI's supporters: a \$500,000 federal earmark from Congressman Danny K. Davis (IL-7th), \$400,000 in state funding led by Senator Lakesia Collins (5th District), and a combined \$250,000 from Republic Services and Rebuilding Together.

During the ribbon-cutting, Dew presented awards to key champions, including Congressman Davis, Senator Collins, and Illinois Senate Majority Leader Kimberly Lightford (4th District), though she was unable to attend. Representatives accepted on behalf of ProvenIT (Emmanuel Agbarah), Republic Services (Deon Mitchell), and Rebuilding Together Metro Chicago (Chad Ruckauf).

RICHMOND DELEGATION VISITS HSI TO STUDY HBCBO MODEL

Habilitative Systems, Inc. recently welcomed members of the National Association of Black Social Workers (NABSW) from Richmond, Virginia, for a special visit focused on HSI's Historically Black Community-Based Organization (HBCBO) Initiative. The visit was part of an effort to learn more about HSI's pioneering model that aims to elevate, connect, and strengthen Black-led nonprofits working to close critical gaps in the social safety-net.

During their time in Chicago, the delegation toured two HSI program sites and engaged in meaningful dialogue about how individual, often isolated, nonprofits can unite to share ideas, pool resources, and build collective strategies to serve historically marginalized communities.

In addition to learning directly from HSI's leadership and staff, the visitors had the opportunity to meet with prominent public officials, including U.S. Congressman Jonathan Jackson (01-IL) and Chicago Mayor Brandon Johnson, both strong advocates for community-based solutions and equity in healthcare and human services.

The exchange marks an important step in expanding HSI's HBCBO model beyond Chicago and sharing best practices nationwide.

HSI SHOWCASES TRAUMA-INFORMED WORK AT MIDWEST PSYCHOLOGICAL ASSOCIATION ANNUAL MEETING

Habilitative Systems, Inc. was proud to participate in the 2025 Midwest Psychological Association (MPA) Annual Meeting, held in April at the historic Palmer House Hilton in Chicago. HSI co-presented a poster session in partnership with the University of Illinois at Chicago – Urban Youth Trauma Center (UYTC), spotlighting collaborative research and programming addressing trauma among urban youth.

The session featured the work of Dr. Jaleel Abdul-Adil, Co-Director of UYTC; Dr. Karen Barbee-Dixon, Chief Operating Officer at HSI; and Chaundra Van Dyk-McGee, Director of Special Program Initiatives at HSI. Their joint poster presentation explored innovative strategies for trauma response and healing in underserved communities.

Also featured at the meeting was a highlight of HSI's recently completed Trauma-Informed Care Initiative—a comprehensive, yearlong project culminating in the development of a customized HSI Model of Care. This model was shaped by the collaboration of eight esteemed scholarly consultants and HSI leadership and staff. Designed to promote healing and empowerment for families impacted by trauma, the model embraces a holistic approach—weaving

Held at Fairlie Chicago in May, the event marked the start of Mental Health Awareness Month and raised funds to support C4’s mission of providing trauma-informed, culturally-relevant mental and behavioral healthcare across the city.

E&R TOWING VEHICLE DONATION BOOSTS HSI'S CRISIS AND 988 OUTREACH

A generous donation from E&R Towing is helping Habilitative Systems, Inc. (HSI) reach more people in crisis. The company donated a 2016 Kia vehicle that HSI will use across two critical programs: its Crisis Services Program and the 988 Suicide and Crisis Lifeline Response. The vehicle will expand the organization's capacity to deliver in-person counseling, intervention, and outreach to communities across Chicago, Berwyn, Cicero, and Stickney.

HSI is one of four providers working to build a coordinated crisis care system on Chicago's West Side. With this vehicle, HSI will strengthen its connection to services like the Crisis Counseling and Wellness Community Center (CCWCC), a walk-up facility for mental health assessment and intervention. Mobile outreach is a vital piece of ensuring that those in need aren't

institutionalized, incarcerated, or left without help during a mental health emergency.

The vehicle will also support HSI's flood recovery outreach under a contract with the Illinois Department of Human Services. After historic flooding in Cook County, HSI is helping affected residents access counseling, housing, and other resources. The vehicle will assist teams distributing information, conducting FEMA surveys, and connecting people to care.

As part of its 988 programming, HSI also delivers bullying and suicide prevention training throughout Chicago. This vehicle will enable HSI to take these educational workshops directly into neighborhoods, increasing access to mental health support and ensuring timely intervention where it's needed most.

ILLINOIS HEALTH PRACTICE ALLIANCE HELPS HSI OFFER INTERNSHIPS

With funding from the Illinois Health Practice Alliance and other grantors, for the past three years, HSI has offered paid internships to Master of Social Work (MSW) students interested in careers in community mental health. We have hosted 12 students from Aurora University, Chicago State

University, DePaul University, Northeastern Illinois University, and the Jane Addams School of Social Work at the University of Illinois at Chicago. Many of our students were career-changers, with backgrounds ranging from nursing to information technology to performance opera.

While learning firsthand about serving primarily Black and Brown, marginalized community members, our students have provided more than 7,000 hours of trauma-informed service in our outpatient mental health, intensive care management, violence prevention, developmental disabilities, supervised residential, and substance use disorder programs. Our students have moved on to careers as therapists, senior care managers, hospital social workers and other areas. One student is now working on his Ph.D. in social work and a second will be starting his Ph.D. program this Fall.

HSI LAUNCHES CULTURAL FAITH-BASED MENTAL HEALTH INITIATIVE

HSI has launched a new Cultural Faith-Based Program through its Special Initiatives Department, aimed at strengthening mental health advocacy within faith communities. The initiative equips faith-based organizations with tools in community organizing and resource development to build sustainable, independent mental health efforts.

Leading the initiative is Rev. Ira Acree, a respected faith leader with deep ties across Chicago's religious and civic networks. Rev. Acree drives community engagement and promotion efforts, working alongside an HSI Case Manager with expertise in mental health and substance use support.

The program focuses on expanding access to care by providing direct referrals, supportive services, and advocacy—particularly for individuals affected by behavioral health conditions.

Serving the Austin, North Lawndale, West Garfield Park, and Humboldt Park communities, the initiative is funded by the Illinois Department of Human Services (IDHS), Division of Mental Health. It is led by Chaundra Van Dyk-McGee, HSI's Director of Special Initiatives, who brings deep experience in advocacy and community engagement.



DONALD DEW SHOWCASES HSI HBCBO LEADERSHIP AND IMPACT AT NATIONAL ASSOCIATION OF SOCIAL WORKERS CONFERENCE

Habilitative Systems, Inc. (HSI) President and CEO Donald J. Dew presented at the 2025 National Association of Social Workers (NASW) Conference in Chicago in June, spotlighting the growing national movement of Historically Black Community-Based Organizations (HBCBOs) which was launched last year by HSI.

“Community-based organizations like HSI have stood in the gap for decades,” Dew said, “addressing the deep-rooted challenges in African-American communities — from healthcare disparities and poverty to homelessness, mental illness, substance use, and violence.”

As an example, he showcased HSI’s comprehensive services which span a wide range of behavioral health and social service programs, including adult mental health, crisis counseling, employment and training, emergency housing and gun violence prevention and restorative justice. HSI has supported underserved communities in Chicago since 1978.

“Community-based organizations like HSI have stood in the gap for decades”

He also shared HSI’s Five-Year Impact Report which showed that HSI has served 1,140 clients across its core behavioral health programs. Notably, 100% of youth in HSI’s mental health services have avoided psychiatric hospitalization, 85% of participants in substance use recovery programs have maintained sobriety, and recidivism among court-involved youth in outpatient mental health programs is 0%.

With over 8,000 individuals served annually, a \$15 million operating budget, and services delivered at 17 sites across Chicago, HSI continues to lead by example—building culturally responsive systems of care and empowering other Black-led organizations to thrive.

“This work is not about charity,” Dew said. “It’s about justice, equity, and creating sustainable systems that reflect the voices and values of the communities we serve.”
